through GM's parts tracking system.

Forty-three hundred twenty-four 2019 model-year Chevrolet Silverado 1500

vehicles are known to be affected by this recall.

Two 2020 model-year Chevrolet 2500/3500 vehicles are affected by this recall. Eighteen hundred sixty-one 2019 model-year GMC Sierra 1500 vehicles are

known to be affected by this recall.

Two 2020 model-year GMC Sierra 2500/3500 vehicles are affected by this recall. Four hundred forty-five parts were not associated with a specific VIN at the time

of sale.

Description of Defect:

Description of the Defect: General Motors has decided that a defect which relates to motor vehicle safety

exists in certain tri-fold tonneau covers sold as accessories for 2019 modelyear Chevrolet Silverado and GMC Sierra 1500 series (LD) trucks and 2020 model year 2500/3500 series (HD) trucks. The tonneau cover may become

loose and could detach from the pickup bed while driving.

Description of the Safety Risk: If the tonneau cover detaches from a moving vehicle and falls into a roadway

it may increase the risk of a crash.

Description of the Cause: The tonneau cover's attachment system may not sufficiently secure the

tonneau cover when exposed to vibration and wind forces. As a result, the

attachments may loosen and disengage.

Chronology:

On March 6, 2019, GM received two reports that a hard, tri-fold tonneau cover detached from 2019 Silverado/ Sierra light-duty trucks at highway speeds. On March 7, GM's Brand Quality Manager submitted this report to GM's Speak Up For Safety (SUFS) program. Between March 22 and April 5, 2019, GM learned of three more related reports of tonneau covers becoming loose or detaching while driving. On April 9, 2019, GM opened a safety investigation. GM received two additional reports of tonneau-cover issues on April 11 and 13, 2019. Following an analysis of field data and a review of the investigation in GM's Global Open Investigation Review, on April 17, 2019, GM instructed dealers to stop the sale, installation, and delivery of these tonneau covers and all vehicles on which the tonneau cover had been installed as an accessory. On April 18, 2019, GM's Safety Field Action Decision Authority (SFADA) decided to conduct a safety recall.

loosening while driving. Pursuant to 577.11, GM will provide

reimbursement to owners for repairs according to the plan submitted on

May 19, 2017.
